On behalf of the Association of Population Centers (APC), I am proud to share with you the 2020 edition of the *APC Resource Guide*, a compendium of individual profiles of the nation's premier independent population research organizations. In these pages you will find a comprehensive overview of the current state of population science including research subject matter, interdisciplinary and cross-institutional collaborations, and applications to real-world decision-making and policy development.

Founded in 1991, the Association of Population Centers is an independent group of university-based centers and private sector research organizations whose mission is to:

- · Foster collaborative demographic research and data-sharing
- Translate basic population research for public policy decision-makers
- Provide educational and training opportunities in population studies

Approximately 40 distinct entities comprise the APC, including broad-based population centers as well as several centers focused specifically on aging populations. All the centers are by design interdisciplinary, drawing faculty and research staff from diverse fields such as demography, economics, geography, medicine, public health, biology, public policy, and sociology. Scholars at APC centers conduct research on the individual, societal and environmental implications of population change. Their diverse interests include topics such as retirement, minority health, aging, adolescent health, childcare, immigration and migration, family formation and dissolution, fertility, morbidity and mortality, post-disaster resilience and population forecasting. This research, in turn, serves to inform planning, policy formulation and decision-making at the local, regional, national and even international levels.

APC centers rely on an array of public and private funding sources to support their scientists' research. The National Institute on Aging and the Eunice Kennedy Shriver National Institute of Child Health and Human Development at the National Institutes of Health provide most of the competitive federal funding for demographic research. The National Science Foundation and the Agency for International Development are two other important sources of federal support. Population researchers also rely on accessible data produced by the Census Bureau, the National Center for Health Statistics, the National Center for Education Statistics, and the Bureau of Labor Statistics to conduct their research.

Research to Policy

- Senator Andrew Jones, R-Centre, of Alabama, put forward an opioid education bill—the Patient Opiate Risk Education Act—that would require medical practitioners to educate patients about the addiction and health risks involved with prescription opioids. Senator Jones cited the findings of a study by recent HCPDS postdoctoral researcher Lyndsey Rolheiser, PhD, faculty member S V Subramanian, PhD, and a colleague that identified his congressional district as having the highest opioid prescription rate in the United States.
- The Alfred P. Sloan Foundation has funded the development of a book project that gathers an interdisciplinary community of top scholars to examine how the contexts that shape individuals' likelihood of working longer are changing across cohorts, and how some population groups—especially racial minorities and lower-income workers—are impacted more than others. The resulting volume of new research (to be published in 2021) has the potential to influence public policies that improve the workplace for older employees, and to increase the public's understanding of aging and labor force challenges.
- Currently, public policy decisions in India are based on data that is collected and reported at broader levels (e.g., districts or states) and does not align with the geopolitical units represented by elected politicians. Faculty member S V Subramanian, PhD, and visiting scientist Rockli Kim, ScD, have been awarded a \$2.2 million dollar grant by the Bill & Melinda Gates Foundation with the aim of leveraging novel geospatial and statistical methodologies in order to provide policy makers in India with more precise and targeted health data on their constituents.

Research to Policy

- The Council's research on worker health in Cambodia included assessing the policy landscape, garment worker needs and living conditions, and outcomes of ongoing programs. The research galvanized efforts to prioritize reproductive health access, resulting in new Ministry of Labor and Vocational Training guidelines to include related services in workplace infirmaries.
- Population Council researchers collaborated with the Tanzanian National AIDS Control Programme to demonstrate the acceptability of and identify opportunities for introducing oral pre-exposure prophylaxis (PrEP) for adolescent girls and young women.
